Conditions of participation	According to FCI Regulations for International Lure Coursing Events, each dog entered to this race must have a valid racing or coursing licence. All competitors must carefully follow the race schedule, so the trouble free progress of the race can be ensured. The FCI judging system is used.
Jackets and muzzles	Racing jackets in red and white color without numbers. Muzzles are required for all breeds!
Race schedule	Selection of pairs of dogs for the first run is done by the random selection. In case of an uneven number of entries the organizers will try to find a companion dog, where possible, to avoid a solo run. In the second round, the dogs will be arranged upwardly by the score of the first run. In case there are less than 6 dogs on the start from each sex,

	males and females run together.

Veterinary conditions	The dogs must have a passport with a valid vaccination against rabies. The veterinary control is required for each dog before the first round. The dogs which were excluded by the veterinary cannot start in this race.  The veterinary confirms in the pet passport or in an accompanying document that the dog shows no clinical signs of disease and is able to withstand carriage to its destination at the time of issuing the confirmation.  Dogs older than 6 years and younger than 2 years must pass the veterinary check before the second round too.
Dope testing	All kinds of doping are forbidden. Doping tests follow the National coursing rules of Slovakia.
Misconduct by owners or handlers	All the dog owners / handlers must behave according to the following rules: do not let the dog free of the leash, do not cause property damage or material damage, eventually do not interfere the course of the race. The owner / handler whose dog breached one of these rules can be charged with a financial penalty of € 25. The Lure Coursing Director, in conjunction with the judges, is authorized to exclude and dismiss anyone from the race / event who does not follow the instructions of the race officials, who insults them or behaves improperly without any fee's refund.
Responsibility disclaimer	Neither the organizer, nor the officials are responsible for injuries incurred by the dog owners, the dogs or the officials. Likewise they accept no responsibility in case of escaped / lost dogs. The owner of a dog is not responsible if his dog injures another dog during the race. In all other cases the dog owner has the full responsibility for the dog.
Protest	The protesting person must pay a fee of $\in$ 100 to the race organizer. If the protest is legitimate and justified this fee will be paid back. The Lure Coursing Director, in conjunction with the judges, is authorized to reject the protest. The organizer will write a Coursing report about the race and send it to the Coursing Committee together with the protest description and its solution / result. It is not possible to give a protest against the judge's decisions.
